

Now that we've started another new decade, it's time for the National Census. So, why should you be concerned about the Census and ensuring that everyone in Thomas Township is counted? The 2020 Census represents an opportunity for you, your family and your neighbors to maintain the quality of life that we have in both our community and our State. It's also a simple way for each of us to indirectly help control both State and local taxes. The reason that this is true is because Federal funds are distributed to

State governments across the nation largely based upon population. The more people the State of Michigan can identify in the Census, the more federal funds that are allocated to Michigan. For the State, that can translate into approximately \$1,800 per person per year in Federal funding support. Likewise, the State then shares some of that funding with local governments largely on a population basis in the form of State Shared Revenues. For Thomas Township, this is our number one revenue source providing $39\% \pm$ of our operational revenues. So, if there is a drop in the State Shared Revenues in some other way or dip into the rainy day fund.

For the same reason, the Census also helps to fund infrastructure for new roads and highways. We can all agree that Michigan roads are in need of major repair; however, they could be in even worse condition if Federal funds were reduced. It also helps with housing and foster care as well as Medicare and Medicaid. Maybe you don't use these



programs, but there is a good chance that someone you know does. If residents are not included in the count, we lose some of that funding to help those who need these programs. Non-Profit Organizations do their best to help those in need but they become heavily relied upon when State funding is cut. Let's make sure everyone gets what they need from these programs.

Lastly, Census data determines our State's representation at the Federal level of government. We lost a congressional seat after the last Census. This could happen again unnecessarily if we continue to lose population due to uncounted citizens. These seats ensure that Michigan residents are heard and that our needs and concerns can be addressed in Washington. Beyond that, Census population numbers can influence a variety of political issues, as well as drive economic development and other important social aspects of our State.

Be counted. It's more than just a 10 minute survey!

Christmas Tree Disposal

Residents in all 34 communities served by the Mid Michigan Waste Authority can put their fresh Christmas trees to the curb by 7 am on their regular trash day throughout the month of January. You do not need to remove ornaments, tinsel, garland or other decorative items, and trees can be put to the curb with or without a tree bag.

Trees that are frozen to the ground or covered with snow will not be collected until they can be safely accessed by the driver. Large or heavy trees may have to be picked up by the bulk truck, and in those cases, trees should be collected within two days of the resident's regular service day.

The service applies only to Christmas trees that have been used as indoor holiday décor. State law prohibits yard waste and vegetation from being disposed of in the landfill; however, the ban does not apply to Christmas trees. Artificial trees may be placed to the curb as a bulky item at any time of the year.

It is very important to remember that because the weather is so unpredictable in Michigan, it is important to clean sidewalks as soon as possible so they do not get packed down from an accumulation of several snow falls.

Ticket Revenue

It's a warm sunny day and you are driving down the road with your windows down, jamming to your favorite radio station. All of a sudden, you see a police car behind you. You look down at your speedometer and it's over the speed limit. Your heart starts beating faster, you start to sweat, and you're saying to yourself "Please don't stop me." Then, you see the red and blue lights, so you pull over to the right shoulder and the police car follows you. In the end, you receive a civil infraction speeding citation.

You start thinking that the officer needed to meet his quota, the department needed more money, or the officer gets a bonus for the number of tickets he issues. None is true, in fact, most officers do not like to write tickets however it's part of the job.

You're probably wondering where the money goes. To answer that, it depends if the citation is written under state law or local ordinance. Since we live in Thomas Township, we'll address the local ordinance because that's the most common citation written by the Thomas Township Police Department.

Going back to the speeding citation you received, you go to the courthouse and

pay, for example, \$145 for the ticket. You say to yourself that all of the \$145 is going to Thomas Township. Wrong! There are court costs, court fines and a set fee for the Justice System Assessment (JSA) within that \$145. The JSA fee is currently set at \$40 for each civil infraction ticket. After the \$40 is taken out and deposited into the JSA fund; that would leave \$105 for Thomas Township. Wrong again. Two-thirds of the \$105 (\$69.30) will go to the Court funding unit, which is Saginaw County. Thomas Township will receive the other third of \$34.65.



If we use the number of violations in 2018 by Thomas Township, which was 813 and multiply it to \$34.65, Thomas Township would receive \$28,170.45 in ticket revenue for 2018. This goes into the Townships General Fund, as mandated by the State, and not into the police budget. The \$35 amount used is on the low end of the fines and court cost in 2018. You can say that writing citations creates revenue, but the revenue it does create is a drop in the bucket.

The figures used were from the 2018 House Fiscal Agency Memorandum for the recommended range of fines and costs for civil infractions for first-time offenders, responsibility admitted, non-accident violations.

Public Works: A Year in Review

It is amazing how fast the year goes by. Just yesterday, the spring flowers were blooming, now all the leaves are gone. This time of year, we all seem to look back at ourselves and reminisce, so this article will highlight the efforts of the Department of Public Works over this past year.

Public Works operates and maintains the water distribution system that includes over 115 miles of water mains, 933 fire hydrants, 1,703 valves and services 4,781 residential, commercial or industrial customers. From December 2018 through November 2019, we provided 794,855,000 gallons of water (or an average daily water use of 2,379,806 gallons per day). Over the past year, staff repaired or replaced 557 water meters and added 14 new customers. Your Public Works staff also responded to water related issues for the year that included 220 "Check for Leaks" or follow-up requests, helping residents and business owners alike find the causes of high water uses through leaky fixtures and water services. These efforts saved those customers potentially thousands of dollars in wasted water use. We also completed a couple of water system improvements to maintain the reliability of the water supply. Finally, staff performed maintenance on our fire hydrants, including repainting 367 of them.

The Public Works staff also operates and maintains the sanitary sewer system that includes over 67 miles of sewer mains, 700 manhole structures and 15 sewage pumping stations located throughout the Township. The sewer system services 3,376 residential, commercial or industrial customers. From December 2018 through November 2019, we discharged 445,734,000 gallons of sewage, or an average daily discharge of 1,221,189 gallons per day for treatment and disposal. Besides the maintenance and operation of the water and sewer system, staff also provided over 2,029 underground utility location services through the MISS DIG system.

Buildings and facilities generally fall within the responsibilities of the Public Works Department. This year staff performed landscape maintenance, painting and cleaning services to 7 different buildings or grounds including the Township's Owen Cemetery. Some significant improvements were made at the Owens Cemetery entrance where we installed a beautiful arched entrance. We also inspected over 25 miles of sidewalk and performed preventive maintenance on 30 sidewalk pads by removing tripping hazards. These efforts saved residents and businesses the cost of having to replace the sidewalks at their expense) Public Works staff replaced the Gratiot Road Banners numerous times over the course of the year and of course completed the Holiday decorations seen throughout the Township. A special shout out goes to our seasonal help this year: Mark, Dave, Jeffrey, Nolan, Gene and Mike. Without their hard work, Public Works would not have been able to accomplish the little extra things that make Thomas Township a great place to live.

Fire Hydrant Accessibility

Fire hydrants are strategically located throughout the Township and are used in emergencies to combat fires of all sorts. With wintertime upon us, we ask that you help us keep snow away from any hydrant. Please keep a three foot radius around the hydrant snow free. Hydrants can be difficult to see in the dark and when they are buried in snow, it becomes even more of a challenge when every second counts.

Please do not plow snow against a fire hydrant. You are not only making it difficult to get to it in emergencies, you are likely damaging the water pipes connecting the hydrant to the water mains underground. You never know, the next time that hydrant is needed, it may be for your home.



Residents Answer the Call for Helping Our Community

The Thomas Township Fire Department has gained five new committed members this year! They are residents who have said they want to help their community by helping their neighbors in need within the Township. We noted a need for additional fire fighters on signs located at both Fire Stations. When we ask for people, we need people who are willing to dedicate a large amount of time towards helping our community. A background check along with physical and physical agility exams are required before applicants can go on to the rest of the hiring process and attend medical/fire training classes.

When we have a resident who is in need of the fire department services, there are now 29 responders available to answer that call. The first two residents to answer the call for help were **Ed Blue and Stephan Allison**. Both are certified in medical, while Ed is certified for fire fighting. A few months ago, we found three more selfless individuals: **Brian Foley, Allen Dalton, and Stephen Pavlik**. Two of the three are medically licensed and all three including one plus on additional member, **Jenna Stevenson**, began the fire academy in December. They will each invest approximately 360 hours in the fire academy. Upon their completion, they will be certified in both fire and medical skills.

As a community, we are extremely fortunate to have these 29 dedicated members who give up so much of their own time to help others. These folks also maintain fulltime jobs, have hobbies, operate households and maintain families. Somewhere in this mix, they still attend training meetings to maintain their quality skills and respond to calls to protect us all.

As you can see, there is more to it than just saying "I am on the fire department." We welcome these five new faces and I encourage each of you to say 'thank you' to all of the fire department members for the hours they invest to protect you and your family.

Flooding, Are You Prepared?

Flooding is not uncommon in our area, as heavy rains often cause flash flooding that swell our local rivers and streams. Flooding can pose many health, safety and economic threats which could force you to leave your home. It is definitely worth the time to learn what to do in case flooding occurs.



What is the difference between a Flood Watch and a Flood Warning issued by the National Weather Service?

- Flash Flood Warning: Take Action! A Flash Flood Warning is issued when a flash flood is imminent or occurring. If you are in a flood prone area, move immediately to high ground. A flash flood is a sudden violent flood that can take from minutes to hours to develop. It is even possible to experience a flash flood in areas not immediately receiving rain.
- Flood Warning: Take Action! A Flood Warning is issued when the hazardous weather event is imminent or already happening. A Flood Warning is issued when flooding is imminent or occurring.
- Flood Watch: Be Prepared: A Flood Watch is issued when conditions are favorable for a specific hazardous weather event to occur. A Flood Watch is issued when conditions are favorable for flooding. It does not mean flooding will occur, but it is possible.

Flood Advisory: Be Aware: A Flood Advisory is issued when a specific weather event that is forecast to occur may become a nuisance. A Flood Advisory is issued when flooding is not expected to be bad enough to issue a warning. However, it may cause significant inconvenience, and if caution is not exercised, it could lead to situations that may threaten life and/or property.

Staying Safe: Floodwater can be contaminated, so minimize your exposure to it when at all possible. If your home does flood, it is best to turn off the main breakers to prevent electrical issues in your home. If you have to travel during this time keep in mind that driving through flood waters can be extremely dangerous and the best practice is to turn around and seek an alternate route. Before any emergency it is always smart to have a plan already in place to ensure everyone's health and safety.

Another good tip is to make sure you have flashlights for events when the power goes out. Never use candles for emergency lighting. If you have a generator, make sure to keep it a safe distance away from the home so that exhaust fumes do not fill your home.


From the Treasurer

Listed below is a sample tax bill detail for an average home in Thomas Township. The only amount of your tax bill that the Township keeps is listed below as "Township". This amount is equal to about 3-4% of your total winter tax bill. Local Operating (general fund) is the amount of money the Township receives to operate everything in the Township, except the Library, Water Department and the Sewer Department.

The Public Safety millage (6-7% of the tax bill) and the Fire millage (1% of the tax bill) offset the majority of the Police Department and Fire Department expenses, but the General Fund must still supplement a large portion of their operations. This holds true for the Parks & Recreation Department as well.

The Township Library also receives its operating income from a local millage, which was voted in by Thomas Township residents. About 2% of each tax bill goes to operate the Public Library in Thomas Township. The remaining 85% of your tax bill is sent to various OTHER taxing jurisdictions such as the County of Saginaw, Delta College, ISD and the local schools.

Assessing Updates

Your 2020 Assessment Notices will be in your mailbox the last week of February. <u>THIS IS THE ONLY NOTICE</u> <u>OF WHAT YOUR ASSESSMENT (SEV); TAXABLE VALUE (TV) AND PRE EXEMPTION WILL BE FOR 2020.</u> If you have any questions about your assessment notice, you should contact the Assessor as soon as your assessment notice arrives in the mail. <u>Do not wait</u>, as you may lose your opportunity to appeal these values.

There is only one time of the year that assessments can be protested, and that is at the March Board of Review. The 2020 March Board of Review is tentatively scheduled for **March 9th & 10th, 2020** (please call to make an appointment). If there is an error in your assessment and you wish to appeal the values, which the assessor placed on your property, you must attend the March Board of Review. If the Board does not agree with your appeal, you may then protest to the Michigan Tax Tribunal; however, you <u>must</u> first appeal to the March Board of Review. The Assessor can be reached Monday, Tuesday and Friday from 9:00 am— 5:00 pm.

Winter Fun in the Parks

Ice Skating & Hockey

There are two ice rinks at Community Park, located behind the Thom-Township Office as Building at 249 N. Miller Road.
