5. Consent Agenda

A. Motion by Streeter, seconded by Ryder-Petre to approve the minutes of June 28, 2011 with the following correction: Unfinished Business – C. – Award Contract for the Installation of Bases and Electrical Work for the Gratiot Road Streetlight Project – "Discussion followed among the DDA members. . . Streeter suggested that a performance bond be required as a condition for approval of the contract. Streeter stated that he was concerned with the . . ." Motion carried unanimously.

 - A. Contract J. Ranck Electric for the installation of ninety-eight (98) streetlight bases and poles along Gratiot Road.

Sika stated that on July 13, 2011, the bid opening was completed for the Gratiot Streetlight project specifically the installation of ninety-eight (98) footings and electrical work. On July 26, 2011, the DDA awarded the bid to J. Ranck Electric for the amount of \$ 279,449.00. Our office asked Spicer Group to draw up a contract for this project. The DDA members were presented with a copy of the contract. Sika further stated that J. Ranck Electric is anticipating starting the project immediately upon final approval of the MDOT permit with completion of the project in early October. Again this is pending a quick MDOT approval and issuance of a permit.

 - A. Banner Cost Comparisons.

Sika stated with the anticipated installation of the banner poles on Gratiot Road, several DDA Board members asked for banner prices. A cost comparison from six (6) banner companies was presented to the DDA members. The prices range from \$415.00 for a basic vinyl banner to \$1,515.00 for a Solarmax (cloth) banner with individually stitched lettering. Most banners can be produced in three to four weeks and include all attachments such as metal clips to hang the banner. At this time no action is necessary. This is for your reference only.

B. Over-the Road Banner Pole Installation Rebid.

Sika stated that the bid opening for the over-the-road banner pole foundations was held on August 1, 2011. One bid was submitted as follows:

Wolgast Corporation - \$14,450.00

Due to only one bid being submitted, we will be rebidding the project the first week in September to a

broader base of contractors. Our hope is that we can get a better price this time.

He further stated that a public meeting will be held with MDOT and the Swan Valley Condo residents and the residents of Swan Haven before the construction begins.
