A. Presentation – Dave Hollis – DDA Infomercial – First Viewing of Proposed Infomercial.

Dave Hollis presented the DDA members with the first viewing of the DDA infomercial. Hollis stated that there are several photographs and videos that need to be submitted. He further stated that when the next draft is completed, he will forwarded it so that the DDA members can view it prior to the next scheduled meeting in March.

10. New Business

A. M-46 (Gratiot Road) to M-52 (North Graham Road) Median Mowing.

Sika stated that last year, the DDA Board asked that staff obtain a cost to cut the median from Meijer to North Graham Road. This included five (5) cuttings at the start of each month beginning with May, 2012. The DDA members were presented with the request for proposal from 2012. The bid was awarded to Ope's, the low bidder at \$2,075.00. This bid was for 2012 with a mutually agreed upon option for one additional year (2013), provided the Township was satisfied with the first year's performance. The DDA approved this bid at the February, 2012 meeting and five cuts were completed starting in May, 2012 and completed in September, 2012.

Discussion followed among the DDA members. Motion by Ryder-Petre, supported by Martin to approve a one year extension to Ope's existing contract for 2013 in the amount of \$2,075.00. Motion carried unanimously.

B. Review Over-the-Road Banner – Shields Summer Festival.

Sika stated that the Shields Summer Festival Board has applied to erect a banner on the over-the-road banners poles in June, 2013 for the annual Shields Summer Festival. Sika further stated that the DDA is responsible for reviewing and approving all applications and banners. The DDA members were presented with a rendition of the proposed Shields Summer Festival Banner.

Motion by Weise, supported by Doyle to approve the Shields Summer Festival Banner as presented. Motion carried unanimously.
