

Logo Use Agreement

WITNESSETH:

WHEREAS, the DDA desires to engage in a public relations campaign and other endeavors to advertise the services, businesses, goods, and benefits of various facilities and merchants within the geographic area of the DDA; and

WHEREAS, the Logo Owner desires to permit the DDA to use the logo of the Logo Owner to conduct the above activities pursuant to the terms of this agreement

In Consideration of the mutual promise herein to parties agree as follows:

1. That the Logo Owner is the sole owner to the rights to the logo attached hereto and marked Attachment A.
2. That the Logo Owner allows the DDA to use the logo and to reproduce the likeness of said logo in any advertising campaign or public relations activities related to the availability of services, goods, businesses, and benefits provided or offered by the Logo Owner or in combination with other Logo Owners within the DDA's geographic area.
3. That the DDA's use of any such logo shall be at no charge;

4. That this agreement may be terminated by either party after 30 days written notice of termination is received by the other party.
5. That there are no oral promises representations, statements, or obligations binding upon the parties hereto unless in writing and contained in this agreement or an amendment thereto signed by the parties.
6. That the Logo Owner hereby waives any and all claims the Logo Owner may have against the DDA, its officers, and employees arising out of/or related directly or indirectly to the DDA's use of the logo.
7. That the Logo Owner releases, holds harmless, and indemnifies the DDA, its officers, and employees from and against any and all liability, claims, and expenses related directly or indirectly to the DDA's use of the logo.
