- A. Motion by Weise, seconded by Gray to approve the minutes of October 26, 2010 as presented. Motion carried unanimously.
- 6. Approval of Expenditures Motion by Weise, supported by Doyle to approve the expenditures as presented. Motion carried unanimously.

- 9. Unfinished Business
 - A. Gratiot Road Bury Utility Lines along Gratiot Road.

Mr. Taylor submitted a project list and preliminary estimates of cots to the DDA members. These proposed projects and estimates were as follows:

- 1. South side of Gratiot Road, completely relocate utility lines \$5,537,400.
- 2. South side of Gratiot Road, bury conduit only \$996,600.
- 3. Streetlights along both sides (River to Meijers Drive) 88 count at 150' spacing \$884,400.
- 4. Streetlights along both sides (River to Meijers Drive) 44 count at 300' spacing \$497,200.
- 5. North side of Gratiot Road completely relocate utility lines \$2,498,723.
- 6. Relocate overhead lines crossing Gratiot only \$100,000.
- 7. Bore conduit in on south side in the future \$2,300,000.
- 8. East entrance sign \$87,200.

Discussion followed among the DDA members. Streeter asked Mr. Taylor why the financing is always figured for seven (7) years? Mr. Taylor explained that this is based on the ability to pay back the money at a rate which was affordable with the money available each year to the DDA. Doyle asked if we knew how much street lighting would cost from Consumers Energy each month and who pays this bill? Mr. Taylor stated that he was not sure of the cost per month; however, there are several ways to have this bill paid each month including but not limited to assessing the cost to the businesses along Gratiot Road or having the DDA pay the bill directly. Doyle stated that she feels the best option at this time would be to install the streetlights along Gratiot Road giving a visible investment for the DDA district.

Motion by Weise, supported by Ryder-Petre, to approve the recommendation as presented in the November 23, 2010 memo from Russ, Taylor, Township Manager, and proceed with the installation of streetlights along Gratiot Road from River Road to Meijer Drive.
