#### **PLEASE READ CAREFULLY**

1. All organizations and groups must register at the Thomas Township Office, 249 N. Miller Road, Saginaw, Michigan 48609. 781-0151
2. The pavilion rental fee is \$50.00 for Thomas Township residents.  
The pavilion rental fee is \$80.00 for non-residents.  
The pavilion rental fee is \$100.00 for corporations.  
After a pavilion reservation has been made, payment must be received in 10 DAYS OR THE RESERVATION WILL BE CANCELLED.
3. Private pool rental fee is \$70.00. The pool may be rented with one week's prior notification. Private Pool Rentals are for Friday, Saturday, Sunday, from 7pm—9pm ONLY.
4. A copy of homeowners liability insurance must be provided to the Township along with the rental fee.
5. Thomas Township residents may reserve a pavilion starting the first business day in January through January 31st. No phone reservations will be taken on that first business day.
6. Non-residents may reserve a pavilion starting the first business day in February.
7. Reservations are on a first come, first serve basis.
8. All pavilion users must police the tables and pavilion area before leaving the park grounds.
9. Motorized vehicles are not to be used in the turf areas of the park.
10. No organizations may reserve the total park for any event or activity.
11. Any variations of these rules must have specified approval of the Thomas Township Parks and Recreation Commission.
12. Thomas Township Parks and Recreation Commission reserves the right to refuse any request for park use
