Library 8207 Shields Drive **781-3770** Thomas Township has begun a multi year installation process of radio based, remote *reading* devices on every water meter. These devices will only transmit water usage information when specifically asked. The system is identical to what nearly every other community in this region is using OR is in the process of converting to. These reading devices are battery powered and transmit information for a few milliseconds at a time. and only when specifically interrogated; much like when a fax machine is awakened to receive a fax. Once the usage information is passed to the reader, the unit will go back to sleep. Because the units work so intermittently and efficiently, the battery life is warranted for 20 years. No continually broadcasted remote device can operate that long on a battery unless it hibernates when it is not needed. Once your meter is converted, the water meters will continue to be read on a quarterly basis.

How can you help us? Since this summer, our staff has been systematically installing or retrofitting these devices. To date, about 15% of the water meters in the entire system have already been converted. In the future, staff from the Public Works Department will contact you to arrange a time for us to complete the conversion of your water meter. The work typically takes anywhere from 5 to 20 minutes to complete and will be done primarily during normal, working hours. Once you are contacted by our department to make an appointment, we will schedule a convenient time for us to visit your home or business. Our staff will arrive no later, nor earlier than 10 minutes either side of your appointment time to complete the work. From the top down, our staff realizes that your time is important. It benefits us all to be on time, every time. That is our promise. These updates are of no cost to you. Thomas Township is a Passport Acceptance Facility



Since 2004, Thomas Township has been designated a Passport Acceptance Facility. We have five employees who are trained passport acceptance agents

and can help you with a full range of passport needs.

Any passport forms you may need are available at our Municipal Offices at 249 North Miller Road or you can visit the US Department of State website at www.travel.state.gov and fill out your forms online to print them off and bring them to our facility for completion and mailing. Thomas Township also offers passport photo printing services for \$10.00. ceptance agents, with multiple tasks to be completed with each passport which is brought in to our office. All of our acceptance agents are trained and must be recertified each year. Furthermore, our agents and facility are tested by the U.S. Department of State on a yearly basis to make sure we are compliant with all of their rules and regulations and to verify we have the required most up to date passport forms in our facility. Since 2004, the numbers of accepted passports we have accepted on a yearly basis have varied, but for the most part we accept between 550 and 700 passports yearly. We accept passport applications Monday through Friday 8:00am-4:30pm. Please allow yourself extra time if you need to fill out your applications on site.

THOMAS TOWNSHIP ARCHERY PROGRAM



The Thomas Township Parks and Recreation will continue to offer both winter and spring archery classes. Thomas Township now has three USA Archery and National Field Archery certified instructors on staff.

When we started the Archery program almost six years ago, we were a test program for the State of Michigan. Thomas Township Archery is now one of the top recreations programs in the State of Michigan. We have been

SPRING ARCHERY PROGRAMS



The Life and History of Chris Thompson



On July 2, 2015, we tragically and suddenly lost one of our Thomas Township Board members, Chris Thompson. Chris Thompson was born on January 16, 1941 in Tiffin, Ohio. A Michigan State graduate, a Veteran of the US Army, a husband, a father and a grandfather.

Chris loved to write. He was employed by the Saginaw News for over 40 year. In this time he held various editorial positions including 30 continuous years as a contributing columnist. For years, his first wife, Judith, and his children served as topics for his columns. After the death of his wife Judith, Chris married Mari (Zimmerman) in 2002. And wrote about their lives as well.

Over the years, Chris was involved in a variety of activities and community services. Chris had worked as a photographer of Big Ten Football, a writer for Booth Newspapers and an editor and columnist for the Saginaw News. In recent years, Chris wrote an opinion column for the Midland Daily News.

Chris has received numerous awards and recognition for his journalism and photography. These awards included first, second and third place along with honorable mention from United Press International and the Associated Press.

Chris was a devoted member of the Thomas Township Board of Trustees, serving on both the Policy and Ordinance Committee and the Liquor License Review

Committee. Chris was also the Chairman of the Thomas Township Zoning Board of Appeals.

Other service groups which benefited from Chris's time were the William B Mershon Chapter of Trout Unlimited, where he served as a board member and the Can-Amera Games served on the Board of Directors. He served as president of the Central Michigan Chapter of Sigma Delta Chis (a professional journalism society), the Great Lakes Press Association and the Gandy Dancers.

Chris continued to support the Michigan State University Alumni club of Saginaw County, the big Brothers organization of Saginaw, the Apple Mountain Ski Patrol, the Saginaw News Spears Bureau, was a coordinator of the Famers Market Table Project, a member of Shields Lions Club and Gus Macker Basketball.

Chris, along with his wife Mari, who was also tragically killed in the accident, shared many activities together. They were both members and served as deacons of the Second Presbyterian Church. They were members of the Saginaw Valley Master Gardner's, volunteered at Beal Botanical Garden at Michigan State University, members of the Midland Artist Guild and avid contributors and supporters of the local art community.

They enjoyed their families, traveling and were active contributors and attendees of the Midland and Saginaw Bay Symphony Orchestras. They also enjoyed frequent discussion with their History of God class.

Chris is survived by his children: Elisabeth Paige (Thompson) Jones and her husband Troy, and Regan Kathleen (Thompson) Bell. His grandchildren are; Allison, Karly, Kendall and Austin Jones. Chris was also survived by Mari's children; Sperry (Zimmerman) Megerian, and her husband Mark; Jon Zimmerman and his wife, Amanda and Margaret (Zimmerman) Cook and her husband Justin. Mari's grandchildren, Kathryn and Courtney Megerian and Jay and Drew Cook.

Chris will be missed by the Township Board and the Thomas Township Employees.

FREELAND SCHOOLS MILLAGE ELECTION

Freeland Community Schools will be having a millage election on Tuesday, November 3, 2015.

BONDING PROPOSAL

Shall Freeland Community School District, Saginaw, Midland and Bay Counties, Michigan, borrow the sum of not to exceed Twenty-Two Million Three Hundred Ninety-Five Thousand Dollars (\$22,395,000) and issue its general obligation unlimited tax bonds in series therefor, for the purpose of: erecting, furnishing, and equipping additions to and remodeling, furnishing and refurnishing, and equipping and re -equipping school buildings; acquiring and installing instructional technology in school buildings; erecting and equipping a bus garage;

purchasing school buses; and developing, improving, and equipping athletic fields, playgrounds, and sites?

The following is for informational purposes only:

The estimated millage that will be levied for the proposed bonds in 2016 is 3.29 mills (\$3.29 on each \$1,000 of taxable valuation). The maximum number of years any series of bonds may be outstanding, exclusive of any refunding, is sixteen (16) years.

The school district does not expect to borrow from the State to pay debt service on the bonds. The total amount of qualified bonds currently outstanding is \$5,495,000. The total amount of qualified loans currently outstanding is \$-0-. The estimated

computed millage rate may change based on changes in certain circumstances.

(Pursuant to State law, expenditure of bond proceeds must be audited, and the proceeds cannot be used for repair or maintenance costs, teacher, administrator or employee salaries, or other operating expenses.)

Winter Tax Bills to Arrive by December 1, 2015

Winter property tax statements are scheduled to be mailed to you on or around December 1, 2015. If a property tax statement has not been received by December 5, 2015, please contact the Deputy Treasurer, Korina Tucker at (989) 781-0150 or by email at treasurer@thomastwp.org to request a copy.

For your convenience, a drop box is available by the south side of the Township office building for making payments after hours. The drop box is checked each morning that the Township holds business hours and all payments are considered received on that day. All payments must be received or postmarked no later than December 31, 2015, to be considered paid in 2015.

If your property taxes are paid by an escrow account, you will receive confirmation of payment in the form of a paid property tax receipt. If you do not receive a paid tax receipt, you may want to contact your bank and make arrangements for payment.

REMINDER

When paying in person, bring the entire tax notice with you (both top and bottom portions) and our staff will mark the top portion paid for you as your receipt.

DPW NEWS



Well, another summer has quickly passed us up greatly exceeding what should be the speed limit for seasons! As we move into the fall, your Public Works will be busy flushing and winterizing all the fire hydrants located throughout the water system. This is a normal maintenance function that is extremely important to ensure the fire hydrant in your area works properly if needed in an emergency. As those flushing activities begin, you may see cloudy water from your water faucets. This is a normal occurrence, and is typical of flushing activities. If your water appears discolored or is cloudy, simply run your water faucets for a short period of time to clear your home's water piping. This flushing activity also means that there will be many areas with standing water or puddles, specifically within the road rightof-ways and along curbing. In some cases, fire hoses or other piping are used to diffuse or to direct water away from potentially pooling areas and yards.

This is an important event that the whole community looks forward to each year, especially the Swan Valley school aged children, faculty and staff.

Thomas Township along with the Thomas Township Police and Fire Departments partners with Swan Valley Schools, Saginaw County Road Commission and Michigan Department of Transportation each year to make sure that permits are obtained, barricades are up and escorts are in their proper places.

<u>Facts about Water Meters</u>

Water meters are extremely accurate and constructed with a precision-machined chamber containing a disc which nutates (which is just a fancy word for wobble). The position of the nutating disk divides the metering chamber into compartment containing an exact volume of water. As the water pressure drives the nutating disc to wobble, a roller causes the disc to rotate completely around within the meter completing a "cycle". Each cycle equates to a measured amount of water and is then transmitted by a gear to an indicator, totalizer or pulse transmitter.

The water meter manufacturing industry standards require their meter to be between 99% and 101% accurate before they are sold to water utilities. Our Township standards require water meters to be accurate between 95% and 100%. As meters are mechanical in nature, they tend to be less accurate as they age and rarely, if ever, measure more water through them than the actual amount delivered.

If you have a hydrant located in your yard, please make sure that plants and shrubs are at least 6 feet away from the centerline of the hydrant. This clear area is necessary so that the hydrant can be quickly located, hooked to and operated in emergency conditions. Thank you for your help.

So how does a water meter work? Once the water flows through the meter, that flow rate needs to be converted to a registered reading. This is done via a mechanically driven-odometer type register mounted atop the water meter. This register counts the gallons passed through the meter as the disc nutates. The odometer count is then transferred to another exterior mounted. odometer-type reader, mounted on the outside of your home or business. Our meter readers then read the outdoor reader, hand write that number on a meter card, and then our water billing clerk enters the handwritten data into the billing software. For these reasons and others, our staff works very hard to make sure that our customers are billed fairly based upon accurately metered water service.

Recently, our specific meters became obsolete as a result of the meter industry switching over to more technology based meters. In 2012, we were notified that the metering devices that have been sold since the 1960's were no longer manufactured or supported. This affected every one of the communities in our region and resulted in all of us having to abruptly reassess our system and modify it so we all could continue to meter water. Since 2013, Thomas Township has elected to modify our system by incorporating remote read metering devices on all 5,500 meters in our system. Using this type of technology will allow our staff to streamline our ability to accurately and safely read your water meter by remotely accessing the device from outside your home or business. Once read the data is downloaded directly into the billing program, eliminating the potential to miss-read or missinterpret the readings.

Fire Department News

THANK YOU SPARKS FARM!

As all of us are aware, North Miller Road had some significant construction improvements going on this year. This construction had an enormous impact upon operations at Station One located on North Miller Road. A lot of people were curious about where we parked the trucks and how we responded to calls with all of the construction taking place on the main access road to the Station.

Our staff began planning in 2014 for this year's construction in order to develop a well thought out plan for maintaining our Department's ability to respond to emergencies in a timely manner within the Station One service area. Having Miller Road closed to only southbound traffic, meant that fire trucks needed to respond via Gratiot to River or Kennely, for anything north of the Fire Station. It might have seemed easier to allow only northbound traffic so the trucks could always just go north; however, the problem with that idea is the majority of our responders live north of the station which prevents them from getting to the Fire Station.

As we analyzed our situation, the specific problem that came to light was our limited ability to quickly access the area directly north of the Station One. It became clear that if we left the trucks in the Station, our response times would probably lengthen significantly for homes north of there. To this end, I approached Bill and Joe Sparks. I explained our problem and proposed a solution of parking a fire truck in their barn to respond from. As with the Sparks Family tradition... and commitment to helping community... they embraced this and offered up two locations to park our equipment.

In light of this, we reassigned a number of fire fighters to this new "Fire Station Three" barn. Yes it was literally a barn much like the days of how fire stations first began. Each firefighter assigned to this station had to carry their fire gear with them, carry a flashlight due to no power and no lights for the night calls and operate much differently in these unusual circumstances. I do appreciate each of their commitment to adapting to this temporary situation. Those assigned to this duty station were Erin Ludwick, Tim Gray, Brian Leach, Tim Woodcock, Safety Officer Drake Parent, Crew Leaders Gary Salo, Peter Stevens and was lead by Lt. Ryan Ludwick. In addition to these folks, the rest of our firefighters also had to deal with many obstacles to get to the station and back home. I appreciate their commitment to doing all of this in the spirit of helping a resident in a time of need.
