Thomas Township along with the Downtown Development Authority (DDA) is proud to honor Thomas Township men and women who have served or are currently serving the United States of America by instituting the **HOMETOWN HE-ROES BANNER PROGRAM.** This program is a way for a service person and or family member to honor and recognize their contribution. The Hometown Hero must be a current or previous resident of Thomas Township. The banners will be displayed on the light poles along Gratiot Road (M-46) for the Veteran's Day and Memorial Day holidays.

The Hometown Heroes applications are being taken on a "first come, first served" basis. Applications will be closed once space limitations have been reached. Taking part in the program will ensure your banner will remain part of the

display for five (5) years. After that, the banners will be replaced (due to issues of fading etc.). The Township will contact the sponsor at that time to return the banner to them. If you wish to continue having a banner as part of the display, you would then have to repurchase a new banner.

You must provide a picture of the honoree to be placed on the banner. It should be provided in "digital" format for the best likeness. It should be understood, that some photos may not produce a likeness that is as clear and of the same quality. The photograph is preferred to be one of the honoree in their military uniform.

Please let us know why you chose to honor this person so that we may publish this information on the Thomas Township website and in the quarterly newsletter to further honor your "Hometown Hero".

The \$110 application fee can be paid by check, cash or money order in person, through the drop off box, or by mail to the Thomas Township Office, 249 North Miller Road, Saginaw, Michigan 48609. Dog Licenses

Dog licenses are available at the Township Office from December 1st, 2020 though March 1st, 2021. At any time outside of these dates you will have to obtain the dog license from the County Courthouse or at your local veterinarians office.

P.A. 195 of 1969, Sec. 6 requires the owner to show proof of valid rabies vaccination including the expiration date to obtain a dog license, Dog licenses will not be issued without the required rabies vaccination information.

Those who complete this process will then continue through the hiring process as well as medical and fire classes.

Brandon and Samantha are currently attending the required medical classes and will be attending the fire academy starting in December. They will each invest approximately 460 hours between the fire academy and their medical certification. As a community, we are extremely fortunate to have a fire department consisting of dedicated members like Brandon & Samantha who give up their own time to help others. These folks maintain other full-time jobs and have family responsibilities. Somewhere in this mix, they still manage to attend trainings and meetings.

As you can see, there is more to it than just saying, "I am on the fire department." We welcome these two new faces and I encourage each of you to say 'thank you' to all of the fire department members you see around our community for the hours they invest to protect you and your family.

In addition to these two responders, we have a new part-time Administrative Assistant in the fire department. **Jean Lisee** joined us in July and replaces Jenna Stevenson who left to attend college. Jean brings several years of experience with her after retiring from Saginaw City Schools. Her personality is already a perfect fit for our organization.

Absentee Ballot Q & A



Applications are available online at https://mvic.sos.state.mi.us/



I received an Absent Voter Ballot Application in the mail and I already filled one out in March and/or August. Do I need to fill this one out?

If you marked the November election on those applications then no. If you did not, then you will need to submit another application. You can check the status on this online at https://mvic.sos.state.mi.us/. Please utilize that service if you can, as our office is already busy with calls and preparations for the upcoming election.

I signed up to always receive absentee ballots so why am I receiving this application?

Voters have the option to be placed on a permanent absentee voter list. This does not mean that they are exempt from completing an absentee ballot application. By being placed on the permanent absentee ballot application list it allows the Township to automatically mail you an application for elections in that current year. The application must be completed and returned to the Clerk in order for the Clerk to verify the signatures and distribute the requested ballots.



Can I return my Absent Voter Ballot Application in the drop box at the Township Office?

Yes the applications can be returned via mail, in-person or by utilizing the secure drop box between the double doors or the one outside the office.

I will be away at school and would like my ballot mailed there. How do I do that?

There is a section near the middle where you can put the start date and end date that you will be at a different location and enter the address you would like the ballot mailed.



How do I know if I am registered to vote and how do I track my absentee ballot application?

Go to **https://mvic.sos.state.mi.us**/ to look up everything from what is on the ballot to whether you are registered to vote and where.

- Mailed in applications must be received by 5pm the Friday before the election. Your ballot will be mailed to you.
- Voters also can drop off their application in person at the Township Clerk's Office by 4pm the Monday before Election Day and get their ballot. The ballot must be voted in the office.

Ballots must be <u>signed</u> and <u>received</u> by 8pm on Election Day.

Vote By Mail, Early Voting and Absentee Voting

The terms "vote by mail" and "early voting" are all terms for voting by absentee ballot in the State of Michigan. A request must be made in writing, including a signature, to the Township Clerk. Once the application is received the clerk verifies the signature with the one on file and if the signatures are consistent, a ballot is mailed to the requested address. Please remember that election mail is not forwardable so list a temporary address on the application if you will be away from home. If the signatures do not match, the clerk will contact the voter by phone, email or postal mail. The voter will be asked to arrive in person to verify the signature.

Ballots are available forty days prior to the election (September 24, 2020). The mailing of ballots to the applications received will begin on that day and can be expected in your mailbox by the first week of October. Voters requesting and picking up absentee ballots in person at the Township Clerk's Office will be subject to the Michigan voter photo identification requirement. Ballots issued in person may only be delivered to the person they are intended. Spouses and family members may return applications, but may not pick up the unvoted ballots for each other. A secure drop box is also available in the vestibule of the Township Office or just outside the building.

Registered voters can apply for an absentee ballot by mail until the Friday before the election. The final deadline to apply for an absentee ballot in person is 4:00 p.m. the day before the election. A signed application must be received by the Township Clerk before an absentee ballot will be issued. The Thomas Township Clerk's Office will be open for in-person voter registration and absentee ballot requests on Saturday, October 31, 2020, from 8:00 a.m. to 4:00 p.m. Voters registering to vote within 14 days of an election will be required to provide proof of residency.

All returned absentee ballot envelopes are processed and tabulated on Election Day. Absentee ballots are counted by an absent voter counting board and the votes are applied to each voter's assigned precinct along with all of the in-person votes cast on Election Day.

Voters should expect to see additional applications sent by political parties and other interest groups. Voters do not need to submit multiple applications for each election. If you have access to the internet you can check your status at https://mvic.sos.state.mi.us/ before filling out additional applications. This link can also be used to view a sample ballot, check the status of your voter registration, locate your polling location and track your absentee ballot. Absentee ballots must be received no later than 8:00 p.m. on Election Day.

All polling locations will be open from 7:00 a.m. to 8:00 p.m. with social distancing and capacity limitations in effect. Please be understanding of possible wait times and exercise your right to vote. Your vote counts.

For your convenience, a drop box is available near the entrance of the Thomas Township Municipal Office building for making payments after hours. The drop box is checked at 8:00 am each morning that the Township holds business hours and all payments are considered received on that day. All payments must be received or postmarked no later than December 31st, 2020 to be considered paid in 2020.

Reminder: When paying in person, please bring the entire tax bill with you (both top and bottom portions) and our staff will stamp the top portion paid for you as your receipt.

Police Chief Addressing Nationwide Protests

Situations are breaking out all around the country. Riots are becoming commonplace along with looting and burning down buildings. I would like to address these riots caused from protesting happening around our country in places like Portland, Oregon; Seattle, Washington; Kenosha, Wisconsin; Austin, Texas; Oakland and Los Angeles, California.

I am not talking about peaceful protesters who are marching for a cause they believe in, I know that some are truly peaceful and being handled correctly. I am talking about the destruction of property, the assaulting of innocent people and the assaults on police officers who are working tirelessly to protect life and property. When protestors are burning buildings with people inside, they are not peaceful protesters, nor are they when they are throwing Molotov cocktails and arming themselves with weapons. You have seen the news clips of riots that are being broadcast on a daily basis; the images of burned out businesses, graffiti all over buildings and the masked rioters clashing with police officers. You have also seen so-called peaceful protesters attacking innocent people in public based on their race or on political affiliation. Such individuals are not protesting peacefully.

Saginaw County has so far escaped the riots and I credit that to the excellent communication that the Police Departments have with their respective community leaders and with their citizens. I feel that we have the same excellent communication with our community leaders and citizens of Thomas Township. Our goal is to continue and improve upon our communication lines with the community.

With that said, I can assure the citizens of Thomas Township and anyone traveling through Thomas Township that the Police Department is committed to upholding the Constitution of the United States and the Michigan Constitution. We will treat everyone, regardless of race, religion or sexual orientation with the respect and fairness that all citizens are entitled to. Any complaints of excessive force will be thoroughly investigated.

As it is one's right under the 1st Amendment of the U.S. Constitution, to protest peacefully, it is not one's right to destroy public or private property. It is not one's right to block traffic. It is not one's right to assault a police officer, a firefighter or anyone else. It is not one's right to burn buildings. It is not one's right to throw dangerous items at police officers.

The Thomas Township Police Department is committed to protecting the citizens and the businesses of Thomas Township and lawlessness and disorder will not be tolerated. The Thomas Township Police Department is working for you 24 hours a day, seven days a week. To the citizens of Thomas Township and to the businesses in Thomas Township, THANK YOU FOR YOUR SUPPORT.

ONLINE REGISTRATION is available for Parks and Recreation Programming. You can access the online registration at thomastwp.org. When using the online registration system to register for Parks and Recreation Programing, you MUST pay for the program you are registering for at the time you fill out the registration form or you will not be considered enrolled in that program. Registration is a two step process. Once you hit *REGISTER NOW*, you will register, agree to the terms and hit *SEND*. You will then be redirected to the payment options on the next screen. From there you should receive a confirmation email of payment. If you do not receive a confirmation, then your payment was not able to be processed and registration will not be able to be completed.

Archery Program

The Thomas Township Parks and Recreation program will continue to offer archery classes this winter. Thomas Township has three USA Archery and National Field Archery certified instructors on staff.

Registration is taking place now and will continue through December 4th, for both the Beginning Archery and the Explorer Archery (formerly known as Advanced Archery) classes. There is a class for everyone's personal skill level!

Beginning Archery is for everyone from age seven through adult! Classes for beginners work on safety, form, equipment and the fundamentals to become a good archer.

Explorer Archery is for archers who have passed our beginner class and can shoot 20 yards with accuracy. Students in the Explorer group will still be honing their skills through games designed to offer a fun yet challenging experience in archery. Classes for Explorer Archers are based on using their equipment if they have it or using advanced set up bows. We have both fully set up compound bows and longbows available for your use.

Classes will be held weekly beginning January 7th at the Saginaw Field & Stream Club, located at 1296 N. Gleaner Road. Classes will continue for six weeks.
