A.-Trail Side Signage-A discussion was held on information provided by Mr. Dave Sommers from a conference he attended with the MTA concerning Trail Side signage that would provide information to those who use the Thomas Township Trail regarding the business corridor. Sika explained that this was being provided to the DDA for discussion only at this time to see if this is something that might be beneficial to draw users of the trail to the business corridor. Sika stated that Mr. Sommers was an avid cyclist and had spoken with individuals who regularly use the trail who weren't aware of businesses/ services that are located in Thomas Township. Taylor added that in meeting with the Parks Director and Sommers they discussed possibly of an arch over the trail and directional signage. Duclos felt that some of the signage examples were too much and actually made a "clean" area look cluttered. Martin said he supported the idea and stated in Leelanau they offered brochures at stations along Their trail to highlight businesses in the area.
