All buildings and paving will be removed from the property, and a new two-lane touchless car wash will be constructed. Vacuum stations will be included along the east side of the building. Turner stated that an MDOT driveway permit has been applied for. He also explained that they are working with the Saginaw County Drain Commission and Spicer Group to work out the capacity of the stormwater detention area. The site will be unmanned at most times, and open 24/7.
