

**NOTICE OF PUBLIC HEARING
TOWNSHIP OF THOMAS ZONING BOARD OF APPEALS**

PLEASE TAKE NOTICE that a regular meeting of the Township of Thomas Zoning Board of Appeals will be held on **June 9, 2026 at 4:00 p.m. at the Thomas Township Public Safety Building located at 8215 Shields Drive, Saginaw, Michigan 48609**, at which time and place a public hearing will be held on the following petition filed with the Township: James Brill is requesting a temporary permit for a period of eighteen (18) days to use a recreational vehicle as a temporary dwelling structure during the term of his Transient Merchant License to sell fireworks at 241 S Graham Rd and the adjacent lot. If granted, the recreational vehicle would be allowed to be used as such for the requested period of time, not to exceed twelve (12) months. Ordinance **Section 21.2 (g)** regulates **Temporary Permits** within the Thomas Township Zoning Ordinance. It requires that, **Temporary permits for temporary structures such as a garage, partial structure, cellar or basement to be used for dwelling purposes, including mobile homes not meeting Building Code requirements or house travel trailer, not located in a licensed mobile home park shall be subject to the following procedures and limitations: 1.) An application for a permit for the erection or movement of a temporary structure for dwelling purposes, including trailer coaches, shall be made to the ZBA.** This is a hearing to solicit comments from interested persons related to this request. Please attend this hearing to give your comments or you may mail them to the attention of the Zoning Board of Appeals prior to the scheduled meeting date.
