New Business:

A. Approve the 2023 Meeting Dates

B. Discussion about Possible New Street Lights on Shields Dr.

Mr. Taylor discussed a possible extension of street lights on Shields Dr. He stated that on Shields Dr, from N. Miller down to Meijer is not very well lit. The estimate of this project is set to be around \$145,000. Mr. Taylor explained that the wires on this project should it be done, would be in conduit this time. Mr. Taylor also explained that eventually Shields Dr will be extended through to Kennely. Mr. Wenglikowski stated that it would make more sense to add lights to Shield Dr. instead of extending the lights on Gratiot to Kennely. Mr. Gray thinks the lights on Shields Dr would be a good idea, but they need to look at the budget to see. Mr. Goward asked if this cost on this would be solely supported by the DDA. Mr. Taylor stated that it depends, he suggested the Township could participate in the cost or that the property owners would be responsible to pay for annual utilities and maintenance.

C. Thomas Township Christmas Party

Mr. Gray stated that there would be an opportunity to attend two parties this night. The Thomas Township party is from 4:00 P.M. to 6:00 P.M. at the Department of Public Works garage. Mr. Gray also stated that the TTBA Christmas party is from 5:00 P.M to 7:00 P.M on the same day.
