- **EXPLANATION OF TOPIC:** We had a very successful event despite two rain days. We were rained both Fridays but both Saturday's were amazing! We made over \$7,000 on the first Saturday and \$9,000 on the second Saturday!

With the addition of the new train in 2022 and our ability to move people faster I feel we need to look at raising the fee for the train to \$10 per person and \$15 for train and haunted house. We raised the fees in 2017 from \$5 per person to \$6 and added a haunted house. There is an additional expense to operate both trains and this will help offset that.
