- A. Motion by Streeter, seconded by Weise to approve the minutes of September 28, 2010 as presented. Motion carried unanimously.

- 9. Unfinished Business
  - A. Gratiot Road Bury Utility Lines along Gratiot Road (South and North Side of Road Comparisons).

At the September 28, 2010 Downtown Development Authority meeting, discussion regarding the options for burying utility lines along Gratiot Road were discussed. The first option mentioned was to install conduit along the south side of Gratiot Road in conjunction with the upcoming watermain project with the anticipation of burying the utility lines in the future. This project would involve placing conduit only into the ground along the area where the watermain would be installed between River Road and Miller Road. A second option was presented regarding burying the utility lines along the north side of Gratiot Road from River to Miller Road. After much discussion, it was determined that further information including cost estimates for boring Gratiot Road needed to be obtained.

Mr. Taylor stated that they have received some preliminary figures from John Olson of Spicer Group; however, some pertinent information is still missing in order to give the DDA a good representation of the costs involved with these to proposed projects. Mr. Radewahn has spoken with some of the local business owners, and he believes that they are looking for a visible return on their investment. Mr. Weise felt that it is important to have a financial plan in order for this project and all proposed projects with the Downtown Development Authority.

Mr. Taylor stated that the watermain project will probably not begin until Spring of 2011; therefore, he would like one more month to gather more definitive costs and present them to the DDA at the November, 2010 meeting. Motion by Weise, supported by Ryder-Petre to table this item for thirty (30) days. Motion carried unanimously.
