## Presentation:

A. Update on the Sewer project

Trevor Schultz from DPW was here to give an update on the projects going on. He stated that the project is in 3 stages, division A, division B, and division C. He said division A is the HSC project and the force main down Geddes. He said that this will be going out to bid here soon and that all the materials are ordered for this project. He said they are still on track to have the project finished by the end of the year with a start date of the end of February or the beginning of March. He then started talking about the update on division B which he stated is the gravity sewer extension. He said that is out for bid as well and all materials are ordered for this have been ordered so they are ahead on this. Trevor stated that with this project, the pump station will be in the house and they plan on making the house look like it fits into the neighborhood. The goal is to keep the residential aesthetic.

B. Update on new Township Office and new Addition to Fire Station #1

Mr. Taylor talked about the potential upgrades that are going to be happening. He showed the plans for the proposed new Township Office and the new Fire Station #1. Mr. Taylor talked about how to location of the Township office will be moving to where the basketball courts are currently that way the new building and fire station line up. He had plans that showed what the outside of the building will potentially look like and a layout of the insides. He also explained that the Township office will have a new feature of a drive-thru making it more convenient for our residents to drop off taxes or water bills.

#### New Business:

A. North Business District

Mr. Taylor talked about something that he would like to see in the future of Thomas Township. Mr. Taylor explained that the "North Business District" would be a continuation of Shields Dr through to Kennely Road. He also kind of explained the look that the north business district would have. He stated that it would be something along the lines of having a business on the bottom floor and living spaces on the above floors. He said the building would be 2-3 stories with different kinds of businesses underneath like coffee shops, restaurants, and dentist offices. He thinks that this could be a great thing for the future of Thomas Township.
