#### A.-Financial Forecast

Radewahn noted that this Financial Forecast is presented to the DDA each year in order to see the funds available. He added that at this time until the streetlights have been paid for there is not really anything available for use which is understandable. He asked for any questions or comments from the members. ### B-Thomas Township Gateway Sign

Radewahn and the members expressed their satisfaction with the rendition of the new Gateway Sign to be constructed on the Township owned property near Heritage Insurance. Martin questioned if the logo sign was a solid sign as it appeared. Watt explained that the logo signed, which was purchased a couple of years ago was a solid metal sign that is to be attached to the portion of arched fencing being fabricated by Able Welding. She added that letters spelling out the "Welcome" message will be attached to the top of the arch. Radewahn asked how soon this construction would be starting. Watt noted as soon as the approval process with MDOT is completed. She also mentioned that Tri Valley construction had been awarded the bid at the September Board meeting to do the Gateway Sign construction.

C-Pocket Park at 7888 Gratiot Rd. (Consumer's Site)

Radewahn asked if everyone had a chance to view the rendition of the "Pocket Park" to be located at the Consumer's Site. It was questioned if this project would be starting this year. Watt explained that the pillars have already been constructed by Consumer's and the hope is to begin the project soon. The members thought this will be a good addition to the business corridor.
