

## Michigan's New Hands Free Driving Law

Even though Michigan's distracted driving law has been in place for more than a few months, I still receive questions from our Thomas Township residents regarding the



terms of the law. It is amazing how often I still see people using their phones while driving. Recently, I was stopped at a traffic light in my patrol vehicle and the person next to me was on their phone, seemingly oblivious to the fact that what they were doing was in direct violation of the law. Below I have provided some of the details of this new law in hopes that it will clear up some questions or

misconceptions of what the expectations are for those driving on our Michigan roads.

Michigan's distracted driving law (Public Act 41 of 2023) went into effect on June 30, 2023. It was an extension of the previous law which had banned the use of cell phones for sending and receiving texts. The new law, dubbed the "hands-free law" expanded the language banning the use of cell phones completely while driving, unless using the hands-free option. Signed by Governor Gretchen Whitmer on June 7, 2023, the distracted driving law made Michigan the 26<sup>th</sup> state to ban drivers from using any handheld device while behind the wheel (48 states have some level of limitation on texting and driving in force). Drivers are prohibited "from holding or using a mobile electronic device while operating a motor vehicle, commercial motor vehicle, or a school bus." The term holding or using means one cannot hold or support a phone or device with any part of their hand, arm, or shoulder. Using a device includes, but is not limited to, the following actions (unless it is through a hands-free option):

- \* Using the device for a telephone or video call.
- \* Sending or receiving texts or email messages.
- \* Watching, reading, or sending video.
- \* Accessing, reading, or posting to social media.
- \* Browsing or using the internet.
- \* Entering information into a GPS or navigation system.

## Michigan's New Hands Free Driving Law (Cont.)

There are a few exceptions to the new law for emergency responders (such as police, firefighters, or ambulance workers) if the use pertains to work. There is also an exception for utility workers. For others, not in these lines of work, the exceptions are limited to making an emergency call and reporting a crime in progress. These are the only times cell phone use is permitted while behind the wheel of a vehicle that is in use.

Police can use the new distracted driver law as a primary or sole reason for issuing a citation, meaning they do not need another reason to stop a vehicle other than seeing the driver using their cell phone or mobile device. The penalties for getting caught increase with each offense. The first offense is a \$100 civil fine and/or 16 hours of community service. For each subsequent offense, the fine increases to a \$250 fine and/or 24 hours of community service. Receive three violations within three years and the driver will be required to take a basic driving course or face a loss of their license. In addition, fines will be doubled if the offense occurs during a vehicle accident. Individuals need to realize the law includes drivers who are waiting at a traffic light. Also prohibited is the use of cell phones that are mounted to the dashboard. Anything beyond a "single touch" is prohibited when it comes to using a cell phone or mobile device by the driver of a vehicle.

Here are a few ideas to help you stay safe and avoid getting stopped by the police when on Michigan roads:

- \* Use voice-activated commands to send and receive texts.
- \* Enter GPS or navigation system information before the start of your trip.
- \* Have an occupant in your vehicle send or read texts on your behalf.
- \* Pull over if you must send or read a text.
- \* Wait until your destination to review your phone activity.
- \* Require that your teenage driver keep their cell phone in the back seat so they are not tempted to check their phone while behind the wheel.

Distracted driving is the leading cause of auto accidents in Michigan. In 2023, there were over 362,000 people injured nationwide in motor vehicle crashes that involved a distracted driver. The new law was created in the

hope of curbing these statistics. By following the new law and the limitations regarding cell phone use, you will not be one of the more than 3,000 people who lose their life each year in a car accident because someone would not put their phone away to drive safely to their destination.

#### **Winter Tax Bills**

Winter property tax statements are scheduled to be mailed out on or around December 1st, 2023. If the property tax statement hasn't been received by December 6th, 2023 please contact the Deputy Treasurer at (989) 781-0150 or you may request a copy through email at treasurer@thomastwp.org

A drop box is available near the entrance of the Thomas Township Municipal Office building for making payments after hours. The drop box is checked at 8:00 am each morning the Township holds business hours and all payments are considered received on that day. All payments must be received or postmarked no later than December 31st, 2023 to be considered paid in 2023.

Reminder: When paying in person, please bring the entire tax bill with you (both top and bottom portions) and we will stamp the top portion paid for you as your receipt.



## Winter Sidewalk Safety Reminder

Although none of us want to admit it, winter will be upon us soon. Even during the frigid winter months, Thomas Township has a large number of walkers, runners, bikers, and four-legged friends who use the sidewalks daily. As Michigan residents, we all know that snow and ice can be extremely hazardous. With this in mind, it is important to address the responsibility of each property or business owner to keep the sidewalk in front of their property clear. The Thomas Township Ordinance requires that within 48 hours of each snowfall, the owner of a property with a sidewalk crossing their frontage must clear the sidewalk of snow and ice. During times when there are multiple days of snow at a time, it is very important to clear the sidewalk as soon as possible. The longer the snow is left to accumulate, the more it gets



packed down by those using the sidewalk, and the more dangerous it can become, and the harder it is to clear. Thomas Township has over 10 miles of sidewalks that connect subdivisions, businesses, parks, libraries, schools, and more.

Keeping these walkways clear and maintained is a monumental task, so next time you're out making use of the sidewalks and see someone shoveling, make sure you thank them for their efforts. # Buying A New Home? Understand how the taxable value uncaps first.

Did you know your property taxes can (and most likely will) increase the year following the purchase of your new home? The reason for this increase is due to Michigan property tax law. A property's taxable value will increase from one year to the next by the rate of inflation or 5%, whichever is less until ownership of the property is transferred or a sale takes place. Once ownership is transferred due to a sale, the property's taxable value is uncapped and will increase to the same level as the assessed value the year following the sale. In most cases, home buyers will see a substantial increase in property taxes depending on the gap between the taxable value and the assessed value of the property.

You may ask why property taxes are uncapped following a transfer of ownership or sale. The answer goes back to 1994 when Michigan voters passed Proposal A. The formula under Proposal A ensures a property's taxable value does not grow as fast as the property's assessed value, which should be at or near 50% of market value. However, once the property is sold, the taxable value is uncapped and increases to the assessed value for the year following the sale. Unaware new home buyers can be in for a real shock if they do not understand this very significant law. Your real

estate agent should be able to explain this to you, if they cannot contact the Thomas Township Assessor to explain what uncapping the property's taxable value will do after it is sold. The Assessor can be reached by phone at (989) 781-0150 or by email at assessor@thomastwp.org.

## **Dog Licenses**

Dog licenses are available at the Township Office from December 1st, 2023 through March 1st, 2024. At any time outside of these dates, you will need to obtain the dog license from the County Courthouse or your local veterinarian's office.

P.A. 195 of 1969, Sec. 6 requires the owner to show proof of valid rabies vaccination with the expiration date to obtain a dog license. Dog licenses will not be issued without the required rabies vaccination information.



## **Chimney Maintenance**

Having a fireplace can add value and an appeal to your home, add ambiance, and be a great method of alternative heating. With having a fireplace, comes the need to maintain it. Depending on how you use or maintain your fireplace/chimney, you may have an above-average build-up of creosote. It is extremely important to properly maintain a chimney and to properly dispose of the ashes. The chimney itself needs to be cleaned out regularly, depending on your usage. There are a couple of



different methods of accomplishing this. One method is to contact a chimney sweep so they can clean and inspect your chimney thoroughly. You can find one simply by putting the words "chimney cleaning", in your internet search bar. Properly disposing of your ashes can be another significant hazard. As hard as it may seem to believe, the ashes can hold heat for several days. It is absolutely dangerous to remove the ashes and place them in a combustible container (plastic trash can or trash bag). It is best to place the ashes in a metal container and keep them outside away from any structure. This may prevent the ashes from starting a fire in your garage, house, or any outbuilding.

Call the fire department immediately if you have or think you have a chimney fire. The Fire Department can respond and check it with a thermal imaging camera which detects heat. We use it to detect areas to ensure you don't have any "hidden" fires. The attic space is one of those forgotten areas where a fire can begin due to a small hole in the chimney which can allow creosote to "flow" out of. honor your Veteran with an engraved brick by simply stopping into the Municipal Office Building located at 249 North Miller Road and filling out an order form. The cost for each brick is \$35.00.

## An update from the Department of Public Works



As we move into fall, your Public Works will be busy flushing and winterizing fire hydrants located throughout the water system. This is a normal maintenance function that is extremely important to ensure the fire hydrant in your area works properly if needed in an emergency. As those flushing activities begin, you may see cloudy water from your home's water taps. This is a normal

occurrence and is typical of flushing activities. If your water appears discolored or cloudy, simply run your water taps for a short period to clear your home's water piping. This flushing activity also means there will be many areas with standing water or puddles, specifically within the road right-of-way and along curbs. In some cases, fire hoses or other piping is used to diffuse or direct water away from potentially pooling in areas and yards.

Additionally, you may or may not know your Public Works Department handles the installation of all Christmas-related decorations that adorn the campus and streetlights on M-46. Prep work has begun for Christmas lighting, and we intend to have everything lit up by the third week in November.

#### **PUBLIC WORKS CONSTRUCTION UPDATE**

Currently, work continues on Geddes Rd. between Gleaner and Kennelly with contractors installing a new sanitary sewer pipeline. Two new pumping stations are being built at the corners of Geddes/Gleaner and Madeline/Sue roads. A new pipeline has already been installed through Rambling Acres and we are just waiting for the asphalt contractor to finish the new road. We are still forecasting that all pipeline work should be completed by the middle of October with road and yard restorations beginning immediately after.

We also have been hard at work re-locating all of the controls out of the flood plain for the pump station near River and State. By adding an on-site generator, installing immersible pumps, and moving all of the controls to State Street, we have essentially floodproofed

## **Archery Program**
