### **New Business:**

### A. Annual Report to Saginaw County:

Mr. Taylor noted that this is the first time monies are being collected off of the revised agreement with the county. The numbers were reviewed by the assessing department for accuracy and sent to Saginaw County. It is expected that the County may have some response. As of today, there has been none.

### B. Update on Retro-Fitting of Gratiot Road Street Lights:

Mr. Rick Hopper, DPW Director spoke regarding the completion of the retro-fitting of the bulbs in the Gratiot Road street light poles. The project actually came in under budget and a special recognition was given to Tyler Branch, a DPW staff member who spent 65 man hours working on the lights. Mr. Taylor added that he'd like to also thank Mr. Hopper and Mr. Sika for a phenomenal job. Approximately \$20,000 for a job that was once believed would be \$300,000. And with this retrofitting, any burnt out bulbs are easily changed by the DPW utilizing their bucket truck and not having to hire an outside electrician to do more in depth work to get the lights working again. To top it all is the daily compliments regarding how good they look. Mr. Radewahn also added his thanks -a good job by all.

### C. Approval of the Gratiot Road Street Light Pole Vertical Banner Calendar:

Mr. Sika explained that a calendar had been sent out in the packets for the vertical banners displayed on the street light poles. It has subsequently been revised to make the installation and removal of the banners more cost effective for Mr. Hopper. The revised calendar is currently being shared on the screen but since all are not attending by Zoom and cannot see it, the calendar will be resent for the next DDA meeting and voted on at that time.
