#### A. Review & Approval of Capital Improvement Plan/Financial Forecast.

He noted that Mr. Sika has been working on locating this new sign at the 7-Eleven located at the corner of Graham and Gratiot Roads. He added that Mr. Sika had finally made contact and that two representatives of 7-Eleven were going to review the site. Hopefully there will be an answer by The next DDA meeting in September as to if the location can be used. The Financial Forecast is now showing some capture of county tax dollars which is a positive note.
