ROAD WORK WINDING UP IN THOMAS TOWNSHIP

The orange road closed and detour signs have been a common sight for drivers around Thomas Township this year. While it is great to see so many of our local roads being improved, we realize that it also means more inconvenience for drivers. The good news is that most of these projects will be winding down as the end of Fall approaches.

Winchester Park subdivision had their roads completely reconstructed through the special assessment process. Each homeowner has taken on a \$3,000 special assessment to pay for the improvements. Meanwhile, the Township contributed \$1,000 per lot to the project through the Subdivision Road Improvement Program. This program is available to other local subdivision roads. Basically, the homeowners pay for 2/3 of the project, and the Township contributes 1/3 or \$1,000/lot, whichever is less. This is in fact the third project that has been completed under this program.

Geddes Road is presently being completed. By November, all of the work should be done resulting in a new driving surface from Graham Road to Miller Road.

Winter Tax Bills to Arrive by December 1, 2009

Property tax statements are scheduled to be mailed to you on or around December 1st. If a property tax statement has not been received by December 5th, please contact the Deputy Treasurer, Korina Tucker at (989) 781-0150 to request a copy.

All payments should be made by check or money order. Many banks and credit unions will issue a check for a withdrawal at no charge or for a small fee.

For the convenience of our residents, a drop box is available at the porch of the Township office building for making payments after hours. The drop box is checked each morning that the Township holds business hours and all payments are considered received on that day. All payments must be received or postmarked no later than December 31, 2009, to be con-

sidered paid in 2009

If your property taxes are paid by an escrow account, you will receive confirmation of payment in the form of a paid property tax receipt. If you do not receive a paid tax receipt, you may want to contact your bank and make arrangements for payment.

REMINDER

Put those paid tax receipts in a safe place, so you know where they are for income tax purposes!

DOG LICENSES FOR SALE

Dog licenses are available at the Township Office from December 1, 2009 through March 1, 2010.

P.A. 195 of 1969, Sec. 6 requires the owner to show proof of valid rabies vaccination including the expiration date to obtain a dog license. Dog licensees will not be issued without the required rabies vaccination information.

Department of Public Works

New DPW Facility to Replace Converted Township Hall

At the Township Board meeting held on May 4, 2009, a contract to build the new home of the Thomas Township Department of Public Works was approved. This contract was awarded to Wolgast Corporation of Saginaw, and was the culmination of many years of planning, budgeting, and design.

The original idea to consolidate all operations of Public Works into one centralized location began in 2004; however, multiple design requirements had to be met to meet the needs of all the different duties and storage issues with which the DPW is responsible. One thing was certain; we needed the facility to be located close to town and the main office. The decision was to locate the new facility on Miller Court, in the very heart of the community. We also wanted the facility to blend into the existing area with a campus feel. The facility would have to be value based and cost effective. Finally, the building would need to be of adequate size for the department's equipment and supplies.

Tasked with operations and maintenance of both the water and sewer systems, the department was quickly running out of storage space for vehicles and the supplies necessary to operate the utilities. The existing storage, located at Frost Road was constructed in the early 1950s. It has undergone several conversions during its lifespan, from the original Township Hall, to a banquet room, and even a dance hall. As the Public Works Department began running out of storage space for equipment and supplies, the building was retrofitted for storage. Today, equipment is still parked on the original oak planked dance floor, and needed supplies are organized on the stage!

With the age of the structure and its poor condition, it became necessary to consider some very large and expensive repairs. The flooring was buckling underfoot and needed replacement, windows and doors needed to be replaced, severe roof and wall damage threatened the integrity of the structure itself, the plumbing was failing. And, regardless of the immediate repairs, the building would still be drastically undersized for storage purposes, and lo-

cated nearly 4 ½ miles outside our normal work area. Based upon these factors, it was determined that a new structure, located in a more strategic area of the community would prove to be more cost effective and a wise use of the funds available. It was also noted that by maintaining operations within the main service area of our community, additional cost savings in fuel, wear and tear on vehicles, and manpower hours would be quickly realized. In 2005, we started to put aside money annually to construct this facility. It was estimated at that time to cost approximately one million dollars.

By late 2008, the estimated costs to construct the facility had risen to 1.646 million dollars, much higher than what would be prudent for the DPW to expend. But in 2009, as the national and regional economy began to stall, material prices and construction costs began to plummet too, in some cases, to 10 year lows. Due to those economic issues, it was decided that this could be a prudent time to advertise for bids to construct this project and perhaps save the community a lot of money.

Great care was taken to encourage local contractors to potentially construct this project. In April, 2009, 12 bids were received. Eleven bids were submitted by local contractors within the immediate Tri-City area. The lowest bid was submitted by Wolgast Corporation, headquartered right here in Thomas Township, for a cost of \$ 994,000.00. This bid represented a significant cost savings to the community of upwards of \$652,000.00, or 40 percent of the estimated construction costs from 2008. Groundbreaking was held on May 26, 2009. The facility is due to be completed by November, 2009.

Your Fire Department has recently added six new dedicated members! These are six residents who have said they want to help their community by helping their neighbors throughout the Township when they are having a bad day. When we have a resident who is experiencing a disaster of sorts and they need to call upon the Fire Department for help, there are now thirty five people eligible to answer that call. These additional selfless people are as follows: Thomas Charlton, Jean Harken, Maynard Lockwood, Mary Miller, Yale Miller and Tom Stoddard.

As a community, we are extremely fortunate to have all of these dedicated members who give up so much of their own time to help others. These folks maintain other fulltime jobs, have hobbies, operate households, and maintain families. Somewhere in this mix, they still attend training meetings to maintain quality skills and respond to calls.

Of these new members, three of them are starting a new chapter in our department. We now have three members of our Department that are dedicated strictly as Medical Responders. These Medical Responders will respond to our numerous daily medical only calls. Upwards of 60% of our monthly calls are medical calls. They will also provide assistance during a fire call by covering secondary medical calls and also provide rehabilitation of the Fire Fighters while on the scene of a fire. This change in the Departments structure will lighten the demands of our on call Fire Fighters, alleviating the need for them to respond to the medical only calls.

As you can see, there is more to it than just saying "I'm on the fire department". We welcome these six new faces and I encourage each of you to say 'thank you' to all of the fire department members you see for the hours they invest to protect you and your family.



THANKS FOR TAKING THE CAKES!

Thanks to everyone who attended our 18th annual pancake breakfast. This annual event has grown into one of the largest projects we undertake. We typically



summon the help of all our personnel and many members also bring their family to make this a success. For the past eighteen years, many of you have supported us through this event. We thank you. We often will get the question what do you do with the money you earn? Well, we don't earn a lot, but what we do

is reinvest in our community. We use this money to fund the bi-annual "Change your Clock Change Your Battery" campaign. In this event, we rotate between our local pizza delivery shops and randomly select homes to accompany the pizza person to the door. If the resident has a working smoke detector, we buy their pizza. If they don't have a working smoke detector, we provide them with a free smoke detector. This has been one of our most rewarding programs. POLICE DEPARTMENT COMMUNICATIONS

In an effort to keep the citizens of Thomas Township informed, we will be publishing, on our website, a listing of complaints taken by our Police Station. Starting in November, these statistics will be published for our residents, exactly as we report them on a monthly basis to the Michigan State Police. These reports are then forwarded to the F.B.I. We are also hopeful that in the future we will be able to show where these incidents occurred by mapping them. As this technology progresses we hope to be able to pass this along also.

It is our hope that by keeping you informed, you can in turn help us by becoming our eyes and ears in the community. If you as a citizen have not been the victim of a crime it is often easy to not be as attentive to things in and around your neighborhood as you could or should be.

The goal of any Law Enforcement agency is the **PREVENTION OF CRIME**, to stop it before it happens and make the risk of being caught so great, that it is not worth the attempt. This lofty goal can only be accomplished with the assistance of every resident. Our community is what we make it, together, as team.

THOMAS TOWNSHIP TRAFFIC VIOLATIONS

The Police Department receives more calls complaining about traffic violators than any other single type of incident. These calls range from incidents of road rage to speeding and virtually everything in between. Ironically, we find ourselves most often criticized for traffic enforcement, quite the catch-twenty-two.

Although traffic issues must take a backseat to 911 calls for service, it remains an important part of the law enforcement function. Without traffic enforcement our roadways would be chaotic. Drunk drivers, persons on drugs and anyone without any regard for anyone else's safety would pose an imminent danger every time you and your family took to the roadways.

We at the Police Department are proud that we have had a positive effect on the safety of our citizens through traffic enforcement. Over the last twenty years, as traffic counts have steadily risen we have maintained an almost level crash rate. Furthermore, the number of fatal crashes have declined from a high of 6-12 a year twenty years ago to an average of less than one a year.

Remember, driving 5,000 pounds of rubber and steel down the road is a full-time job all by itself. A simple mistake can take a life every bit as quickly as a gun. A note to parents, PLEASE talk to your teenage drivers about texting while driving. I see this dangerous habit almost daily in my travels. This could truly be an issue of life or death.
