North Miller Road Construction Update

With the North Miller Road reconstruction project well underway since August 25th, we wanted to give you an update on the progress, along with a brief forecast of what can be expected moving forward. We also wanted to use this opportunity to answer some of the most frequently asked questions about the project. The Saginaw County Road Commission (SCRC) is responsible for the project. They have hired OHM Advisors for engineering oversight and Tri-City Groundbreakers as the general contractor.

Current Status.

The unfortunate part of any road project is the disruption and inconvenience it causes homeowners and drivers who use the road. On that note, we have good news. Despite the predominantly wet weather conditions the contractor has had to deal with, the work is slightly ahead of schedule. In fact, the goal is to still have everything completed in time

for Thanksgiving.

The overall project consists of replacing the water main/services, replacing the storm sewer/enclosing the ditch, removing the old road and constructing the new road with curb and gutter. There are obviously many more minor aspects to the project, but these are the primary work items. The water main and storm sewer are both installed. The new road base has been installed with curbing currently being installed. The curbing is supposed to continue to be constructed between Geddes and State over the next couple of weeks. Once that is done, the base coat of asphalt will be put down on the new road. Meanwhile, a separate work crew will be working on rough grading the yard areas on the back side of the new curb.

Two Phases.

Initially, the Saginaw County Road Commission (SCRC) planned to reconstruct the entire length of North Miller Road

from Gratiot to State. However, due to the late start date resulting from the delay in receiving full funding, the decision was made to split it into a two year project. This year the road between State and Geddes will be completed. Next year's work will be between Geddes and Gratiot. You will see some water main installation yet this year south of Geddes to prepare for next year's construction. The goal is to start the full construction project once school is out for the summer and finish it by the time student's return in the fall. However, you may see Consumers Energy, AT&T or Charter out there working before that time to prepare their underground equipment for the upcoming 2015 project. The detour next year will be the same as this year.

Two Lane or Three Lane.

Initially, the project was drawn as a three lane road the entire length. However, in response to community input and to control costs, the road between Geddes and State is actually a two lane road. Meanwhile, a third lane for left turns will be built between Geddes and Gratiot. This is largely due to the numerous intersecting subdivision streets along this length of roadway.

Signal at Geddes Raod.

Another frequent suggestion that many people have shared is the need to add a signal at the intersection of Geddes. The SCRC has agreed to look into this idea once both sections of the road are completed entirely, so that they can conduct a proper study to determine if a signal is warranted.

Trees.

At this point, we understand that all of the trees that are designated for removal have been removed for both phases of the project. A total of twenty (20) trees were cut down. Of that number, several were requested by the property owner to be removed. The others had to be removed either because they were directly in line with an improvement or they were so close to the road that Federal regulations required that they be taken out. Any trees removed hereafter will be necessitated by the construction or will be a homeowner's decision.

Why This Road?

All of us see the sorry state of many roads around our

community, so it's logical to wonder why is Miller Road being rebuilt. The answer is both simple and complicated. There are various pots of money for funding road improvements. Most of these pots of money are severely restricted by the Federal and State governments such that they are not available to fix the large majority of our roads. They are significantly limited to State highways, primary roads or depressed communities. Townships do not receive a single penny for roads, because they do not have any authority or responsibility for roads.

In any case, the SCRC acquired a competitive nationwide grant for North Miller Road in the amount of \$1.2 million, because it is classified as a primary road due to the volume of traffic using it and its location. In that sense, it was nice to see money coming back to Michigan; rather, than seeing it go elsewhere. The grant was then matched using Road Commission funds and State funds.

With this construction, the perpetually severe drainage problems are being addressed, the height of the road is being lowered, curbing is being added that will eliminate the continuous complaint about stones in yards and the road will be designed to handle the traffic already using it. Without this funding, the reality is that the road would have continued to deteriorate without any possibility of fixing it. The storm water issue would have also continued unless all of the homeowners were willing to pay for fixing it through a special assessment that would have been very expensive.

The History of Thomas Township in Review

THE GROWTH OF TRANSPORTATION

The early settlers in Thomas Township traveled by horse and foot over established Indian trails. As the need to get crops, crafts and good for trade from Thomas Township to other areas for sale, the settlers gradually widened the trails by cutting the underbrush, thus permitting passage with teams of horses and wagons.

The earliest roads in the Township were Tittabawassee Road, Graham Road, North River Road, Dice Road, Thomas Road and Gratiot Road. Gratiot Road grew from a major Indian artery known as the Rainbow Trail to the Indians because it crossed the entire State from Lake Michigan to Lake Huron. As settlers developed their own land, they would build smaller roads along survey lines to the existing roads. They were responsible for maintaining their own roads.

But no matter how the roads were maintained, to get to the city, eight miles away, took the early residents a full day travel, and it was not an easy trip. Before the ferries became operational and the bridges built, rivers and streams needed to be forded (crossed over) by foot or by horse. Sand bars stretched across the Tittabawassee River in many parts making summer travel easier; however, the spring rains and snow melt made the river just about impassable. Due to the necessity of crossing the river, ferries began operating, although the date of the first ferry is not known, records indicate that ferries were operating as early as the 1830's and 1840's.

Bryant's Trip was the location of the first ferry boat operation on the Tittabawassee River in Thomas Township. Crossing the river by ferry was much easier than fording the river. A second ferry was operated on the River at the site of the present day Tittabawassee Road bridge, which is upstream from Bryant's Trip. This second ferry was large enough to carry a team of horses and wagon. These are the only two ferries to operate in Thomas Township, and both operated on a toll payment.

These two ferries operated until a bridge was built across the river in 1870. While the bridge was built on Gratiot Road, it was called State Road at the time. Historians believe it was called State Road due to the fact it was built and maintained by the State.

Subsequently, with the growing population in the northern part of the Township, a second bridge at the site of the Tittabawassee Road crossing was also built. With the passing of county road tax and then Act 59, over 215 miles of road were constructed in the County by 1915.

Railroads were also a major factor in Thomas Township's history. The Saginaw Valley and St Louis Railroad Company was organized in 1873 and it cut



through the southern part of the Township in an east to west direction. There were three depots in Thomas Township.

Only one of the depots was had an

actual scheduled stop. The other two stations were "flag stations" which meant, if there was cargo or people that needed to be picked up a flag was hung up so the engineer knew to stop. A second Railroad



was developed in 1867 and slices through the south eastern corner of our Township. This station was called Paine's Station and was actually located just

over our border in James Township. It was important to the residents of Thomas Township, due to the fact that 14 passenger trains went through the station daily. It was the most cost effective way to bring friends and relatives from different parts of the country to Thomas Township.

The major commodities shipped from Thomas Township were sugar beets, brick and coal all of which were taken to the train stations by teams of horses and wagons. The major incoming commodity by rail was fertilizer, utilized by farmers to obtain higher crop yields.

Winter Tax Bills to Arrive by December 1, 2014

Property tax statements are scheduled to be mailed to you on or around December 1st. If a property tax statement has not been received by December 5th, please contact the Deputy Treasurer, Korina Tucker at (989) 781-0150 or by email at treasurer@thomastwp.org to request a copy.

All payments should be made by check or money order. Many banks and credit unions will issue a check for a withdrawal at no charge or for a small fee.

For your convenience, a drop box is available by the south side of the Township office building for making payments after hours. The drop box is checked each morning that the Township holds business hours and all payments are considered received on that day. All payments must be received or postmarked no later than December 31, 2014, to be considered paid in 2014.

If your property taxes are paid by an escrow account, you will receive confirmation of payment in the form of a paid property tax receipt. If you do not receive a paid tax receipt, you may want to contact your bank and make arrangements for payment.



REAL TIME TRAINING HELPS EVERYONE

At the end of each year, the training division of the Thomas Township Fire Department begins the planning process for our training requirements for the next year. We plan and plot out all mandatory training required by County, State and Federal guidelines. Then we examine the needs and talk to the Fire Fighters about what kind of training they would like to see and what they feel they need.

This year, the Fire Fighters requested additional training in Mass Casualty Incidents (MCI). The training team came up with a list of objectives they wanted covered, and began the logistical process of making this training happen.

While the team of trainers knew what they wanted to teach, the problem we often face is where to do this training. To make this as life like as possible, we need a location where we can spread-out, have a life like emergency scene, but not damage anyone's private property. Thankfully, the Swan Valley School District responded to our request for assistance and provided the perfect venue for a MCI. The emergency scene took place within the shop area of the high school, with a simulated explosion with fire and building collapse which caused a multiple injury scene.

The lead instructors from the fire department were; Ryan Ludwick and Jean Harken. Together they teamed up with high school principal Mr. Craig Blower, teachers Mrs. Kay Wejrowski and Mr. Pat Kennelly. The school not only provided the facility but twenty students who endured being moulaged in "make up" indicating their injuries. Many of them had protruding bones, lacerations, amputations and burns simulating their injuries. Two Mobile Medical Response (MMR) employees donated their time as well to help improve their skills as well as our skills. Special thanks to Mike McEmber and Matt Drake from MMR for their dedication to making this event suc-

cessful.

Having the ability to train in an environment conducive to this scenario with students willing to help in this role, will pay endless dividends to each of our responders as they fine tune their skills. Our personnel gained knowledge and experience far greater than reading about it or practicing on each other. Responding to this incident, putting out a fire, stabilizing a building triaging patients, and performing rapid treatment are just a few skills our crew will posses for years to come. It is cooperation like this that makes our community great and a perfect environment to raise a family.

This training took hours and hours of planning and everyone involved believe it was worth the extra efforts invested by these many selfless people.

I would personally like to thank the members of our department; a paid on call volunteer force who all work outside jobs but yet still find time to give back to their community, for giving of their time and dedication to the betterment of our fire department and the service they provide our community.

Registration is a two step process. Once you hit REGISTER NOW, you will register, agree to the terms and hit SEND. You will then be redirected to the payment options on the next screen. If you have not received a confirmation of payment, you are not registered. Some program sizes are limited, and make sure the form you are using is not out of date.



FALL RECREATIONAL PROGRAMS

BOYS AND GIRLS BASKETBALL CLINICS

DPW NEWS

Well, another summer has come and gone! As we move into the fall, your Public Works will be busy flushing and winterizing all the fire hydrants located throughout the Township. This is a normal maintenance function that is extremely important to ensure the fire hydrant in your area works properly if needed in an emergency. As those flushing activities begin, you may see cloudy water from your home's water taps. This is a normal occurrence, and is typical of flushing activities. If your water appears discolored or is cloudy, simply run your water taps for a short period of time to clear your home's water piping. This flushing activity also means that there will be many areas with standing water or puddles, specifically within the road right-of-ways and along curbing. In some cases, fire hoses or other piping is used to diffuse or to direct water away from potentially pooling areas and yards.

Annual sewer inspection and cleaning will begin the week of September 20^{th} and will continue for approximately 3 to 4 weeks. We will be jetting the sanitary sewers in the area and videotaping that piping for review and study. The areas that will be affected is strictly the commercial area along Gratiot Road.

September 26th brought the Swan Valley High School Homecoming celebration home, highlighted with a parade along Miller Road beginning at Shields Drive and Meijer Drive, continuing to Miller Road, then continuing south to O'Hern to the High School. Public Works worked closely with the Thomas Township Fire and Police Departments on traffic control along the parade route, and there will always be temporary closures at all entrances from Shields Drive, Meijer Drive, Plainfield, Timberwood, Miller Court and North Miller Road to allow for the safe passage of the parade participants.

The Brush site is now closed for 2014. It will reopen for residents beginning April 4, 2015. The hours of operations will continue to be 8 AM to 12 Noon for 2015. The site is open for any Township Resident. No leaves or grass accepted.

The Township Campus has been decorated with Christmas Lights again this year. Look for the Christmas displays to be lit on November 21st. It will be spectacular! Please see the companion article to this on page 6.

You will notice the Christmas decorations on the street lights along Gratiot have changed this year. We are using wreaths with L.E.D light stings to see if they will work better wit the GFI outlets that do not see to say on during wet weather conditions.

CONSTRUCTION UPDATE

Replacement of the new water main on North Miller Road is done. This water main had to be replaced to accommodate the wider road reconstruction project. The new water main between Geddes and Gratiot will probably start in December.

Installation of the River Road to Laurie Lane water main has been completed and is in service. This project increased the water main through the Catholic Diocese's properties from River Road and allowed us to tie two distinct areas together, providing alternative connections to the water system.

Installation of the Coldbrook water main has been completed. This project allowed us to provide the subdivision off Miller Road an alternative water connection, ensuring reliability and enhance water supply.

Rehabilitation of the sewer pumping station located on East Gloucester was completed. The project included new pumps, pipes, valves, and pump controls, and ensured that this important pump station is ready for another 20-25 years of service. As we continue through the season with construction projects, please be mindful of those activities as you travel through and always remember, "Give Em A Brake".
